Professor Salokar's research focuses on the separation of powers, judicial politics, and constitutional reform.

G. ALAN TARR is director of the Center for State Constitutional Studies and chair of the Department of Political Science at Rutgers University (Camden). He is the author or editor of several books dealing with state constitutionalism, including *Understanding State Constitutions* (1998), *Constitutional Politics in the States* (1996), and *State Supreme Courts in State and Nation* (1988).
