## NOTES ON CONTRIBUTORS

**Jeffrey Anderson** is an Assistant Professor of Political Science at Brown University, Providence, Rhode Island. His current research focuses on West German economic policy-making in the context of the tensions and opportunities of European integration and unification with East Germany. He has published articles in many journals including *West European Politics, Governance* and the *Journal of Public Policy* and is the author of a book on regional political economy entitled *The Territorial Imperative* (Cambridge University Press, 1992).

**Peter R. Baehr** is Professor of Human Rights at the University of Leiden and Utrecht and was formerly Professor of International Relations at the University of Amsterdam. He was Executive Secretary of the Scientific Council for Government Policy in the Hague, and was Chair of the Dutch Advisory Committee on Human Rights and Foreign Policy. Publications include, as co-editor, *Policy Analysis and Innovation* (1981) and *Mensenrechten: Bestandeel van het Buitenlands Beleid* (1989).

**J.F.P. Blondel** is Professor of Political Science at the European University Institute, Florence. He was formerly Professor of Government at the University of Essex. He was Visiting Professor at Carleton University, Canada and, more recently, Visiting Scholar at the Russell Sage Foundation, New York. Publications include *Comparative Legislatures* (Prentice-Hall, 1973), *World Leaders* (Sage, 1980), *The Organization of Governments* (Sage, 1982), *Political Leadership* (Sage, 1987) and *Comparative Government* (Philip Allan, 1990).

**Tom Bottomore** has taught at the London School of Economics and was Professor and Head of Department of Political Science, Sociology and Anthropology at Simon Fraser University, Vancouver, from 1965 to 1968. Until 1985 he was Professor of Sociology at the University of Sussex, and has been President of the International Sociological Association and of the British Sociological Association. Publications include *Political Sociology* (Pluto Press, 1979, 2nd edition, 1992), *Theories of Modern Capitalism* (Allen & Unwin, 1985), *Sociology: A Guide to Problems and Literature* (Allen & Unwin, 3rd edition, 1987) and *Elites and Society* (Routledge, 2nd edition, 1992). His current research interests are concentrated on economic sociology.

**Mike Bowker** is currently lecturing in International Relations at the University of East Anglia. He has also taught at Surrey and Essex Universities as well as at Queen's, Belfast. He has published a number of articles on East-West relations and is co-author, with Phil Williams, of *Superpower Detente: A Reappraisal* (Sage, 1988), and co-editor of



*From Cold War to Collapse: Theory and World Politics in the 1980s* (Cambridge University Press, 1992).

**G.R.Boynton** is Professor of Political Science at the University of Iowa. His publications include *Mathematical Thinking About Politics* (1980), *Representatives and Represented* (1975) and *Legislative Systems in Developing Countries* (Duke University Press, 1975). His primary research interests include analytical political theory and the comparative study of legislatures.

**Naomi Caiden** is currently Professor and Chair of the Department of Public Administration, California State University, San Bernardino. She was Chair of the Section on International and Comparative Administration of the American Society for Public Administration (1988–9), and received a National Distinguished Service Award in recognition of outstanding academic contributions from the American Association for Budget and Program Analysis. Publications include *Planning and Budgeting in Poor Countries*, with Aaron Wildavsky, (Transaction Publishing, 1980). Her current research is in public administration and budgeting.

**Ronald H.Chilcote** is Professor of Political Science and Economics at the University of California, Riverside. He is founder and currently Managing Editor of the journal *Latin American Perspectives*, and his many publications include *Power and the Ruling Classes in Northeast Brazil* (Cambridge University Press, 1990) and *The Portuguese Revolution of 25 April 1974* (University of Coimbra, 1987). His research has focused on Portuguese-speaking Africa, Brazil and Portugal.

**Lori Fisler Damrosch** is Professor of Law at Columbia University, where she is also a member of the Faculty of International Affairs. She has served as counsel for the United States before the International Court of Justice and other international tribunals. She is the editor of *The International Court of Justice at a Crossroads* (Transnational, 1987) and *Law and Force in the New International Order* (Westview Press, 1991) and has published many articles on international law and the foreign relations law of the United States. Her current research interests include the settlement of international disputes and approaches to international law in the countries formerly in the Soviet bloc.

**David Denver** is Senior Lecturer in Politics at Lancaster University. His publications include *Elections and Voting Behaviour in Britain* (Philip Allan, 1989) and, as co-editor with I.Crewe, *Electoral Change in Western Democracies* (Croom Helm, 1988).

**Barend A.de Vries** works for the World Bank, and is Adjunct Professor at Georgetown University, Washington, DC. **Paul F. Diehl** is Associate Professor of Political Science and a faculty member of the Program in Arms Control, Disarmament and International Security at the University of Illinois at Urbana-Champaign. He has published many articles on international conflict, arms control and peace-keeping, and is the co-author of *Territorial Changes and International Conflict*, and editor of *The Politics of International Organization*.

**Mattei Dogan** is Scientific Director at the Centre National de la Recherche Scientifique, Paris, and also Professor at the University of California, Los Angeles. He is Chair of the Research Committee on Political Elites of the International Political Science Association. **R. Bruce Douglass** is an Associate Professor in the Department of Government, Georgetown University, Washington, DC, and is co-director of a project examining Liberalism and Catholicism, sponsored jointly by the Department of Government at Georgetown and the Woodstock Theological Center. His publications include *Liberalism and the Good* (Routledge, 1990) as co-editor. Current research includes a study on the fate of individualism in Marx's politics.

**Richard Ellis** is Assistant Professor of Political Science at Willamette University, Salem, Oregon. He is co-author, with Aaron Wildavsky, of *Dilemmas of Presidential Leadership: From Washington Through Lincoln* (Transaction Publishers, 1989) and, with Michael Thompson and Aaron Wildavsky, of *Cultural Theory* (Westview Press, 1990), and is author of *American Political Cultures* (Oxford University Press, forthcoming 1993).

**Tom Farer** is Professor and Director of the Joint-Degree Program on Law and International Relations at the American University, Washington, DC. He has taught at Columbia, Harvard, Johns Hopkins, Princeton, Rutgers and Tulane Universities, and is former President of the Inter-American Committee on Human Rights and the University of New Mexico. His publications include *Warclouds on the Horn of Africa*, *Toward a Humanitarian Diplomacy*, *US Ends and Means in Central America* and *The Grand Strategy of the United States in Latin America*.

**Adele K. Ferdows** is Professor of Political Science at the University of Louisville and a nationally recognized expert on Iran and women in Islam. She has contributed many articles to *Women and the Islamic Revolution* (Westview Press, 1983), *The Iranian Revolution and the Islamic Republic* (Syracuse University Press, 1986) and *Women and the Family in Iran* (E.J.Brill, 1986). She spent the 1988–9 academic year doing research in Iran.

**Elizabeth G. Ferris** is presently serving as Study and Interpretation Secretary for Refugees of the World Council of Churches (WCC) in Geneva, Switzerland. She is researching global refugee issues and is responsible for WCC's programmatic work with refugees in Latin America and North America. She taught Political Science at Lafayette College, Miami University (Ohio) and Pembroke State University, and served as a Fulbright Professor at the National Autonomous University of Mexico. **Lawrence Freedman** is Professor in the Department of War Studies at King's College, University of London. His publications include *The Evolution of Nuclear Strategy*, (2nd edition, Macmillan, 1989).

**Jack A. Goldstone** is Professor of Sociology and Director of the Center for Comparative Research in History, Society and Culture at the University of California, Davis. He is the author of *Revolution and Rebellion in the Early Modern World* (University of California Press, 1991) and co-editor of *Revolutions of the Late Twentieth Century* (Westview Press, 1991).

**Guy Goodwin-Gill** is Professor of Law at Carleton University, Ottawa, and is Editor-in-chief of the *International Journal of Refugee Law*. He is the author of *International Law and the Movement of Persons Between States* (Clarendon Press, 1978).

**Adam Graycar** is Chief Executive Officer of South Australia's Ministry of Higher Education. He was appointed in 1985 by the Government of South Australia as Australia's first Commissioner for the Ageing. He was also Foundation Director of the Social Welfare Research Centre, University of New South Wales. He has taught Social Administration at Flinders University, South Australia, and has held visiting posts at Brandeis University, University of California, Berkeley, Yale University and the Centre for Environmental Studies in London.

**Fred I. Greenstein** is Professor of Politics at Princeton University, and has published numerous books and articles on personality and politics, children and politics, American political parties and the American Presidency. His publications include *Children and Politics* (Yale University Press, 1965), *Personality and Politics: Problems of Evidence, Inference and Conceptualization* (Markham, 1969), *The Hidden-Hand Presidency: Eisenhower as Leader* (Basic Books, 1982) and *How Presidents Test Reality: Decisions on Vietnam, 1954 and 1965* (Russell Sage, 1989).

**Stephany Griffith-Jones** is a Fellow at the Institute of Development Studies, Sussex University. She has worked in the Central Bank of Chile and has acted as consultant to several international organizations, including the World Bank, the European Economic Community, the United Nations Children's Fund and the United Nations Conference on Trade and Development. She has written widely on international debt and international finance.

**Pascale Gruson** is Chargée de Recherches at the Centre National de la Recherche Scientifique and is active in the Centre d'Etude des Mouvements Sociaux, Ecole des Hautes Etudes en Sciences Sociales, Paris. Her current research is concerned mainly with French higher education in the comparative context of Western higher education systems as a whole.

**Philip Gummert** is Senior Lecturer in Government and Technology Policy, and Chair of the Board of Studies in Science and Technology Policy at the University of Manchester. His publications include *Scientists in Whitehall* (Manchester University Press, 1980) and, as co-editor with J. Reppy, *The Relations Between Defence and Civil Technologies*

(Kluwer, 1988). His current interests lie primarily in developments within the defence sector and their impact on industrial and national technology bases.

**P. Edward Haley** is Professor of International Relations at Claremont McKenna College and Claremont Graduate School, Claremont, California and is Senior Research Associate at the Keck Center for International Strategic Studies. He has served as Academic Vice-President and President of the University of New Mexico. He was Professor of Political Science at the University of Michigan, Ann Arbor, and was President of the American Society for Public Administration. His publications include *Public Administration: A Comparative Perspective* (4th edition, Marcel Dekker, 1991).

**Barry Hindess** is Professor of Political Science in the Research School of the Social Sciences, Australian National University. His publications include *Freedom, Equality and the Market* (Tavistock, 1988), *Choice, Rationality and Social Theory* (Unwin Hyman, 1988) and *Political Choice and Social Structure* (Edward Elgar, 1989).

**Leslie Holmes** is currently Professor and Head of the Department of Political Science at the University of Melbourne. He has taught at the Universities of Essex, Kent and Aberystwyth, and has been on the Executive Committee of both the British National Association for Soviet and East European Studies and the Political Studies Association

of the UK. He is on the editorial board of the journals *The Australian Journal of Slavonic and East European Studies* and *Politics*. His publications include *The Policy of Process in Communist States* (Sage, 1981) and *Politics in the Communist World* (Oxford University Press, 1986). His current research interests are change in the Soviet Union and Eastern Europe and the establishment of Special Economic Zones in the Soviet Union.

**Ole R. Holsti** is Professor of Political Science at Duke University, Durham, North Carolina, and has taught at Stanford University, the University of California, Davis, and the University of British Columbia. He has won many awards, including the Nevitt Sanford Award for Distinguished Contributions to Political Psychology in 1988. He was President of the International Studies Association from 1979 to 1980, and served on the council of the American Political Sciences Association as well as on the Advisory Board of the University Press of America. He has written numerous articles and his publications include *American Leadership in World Affairs: The Breakdown of Consensus* (Allen & Unwin, 1984) and, as co-editor, *Change in the International System* (Westview Press, 1980).

**Kenneth R. Hoover** is Professor and Chair of the Department of Political Science at Western Washington University. He has been Senior Fellow at the Center for Twentieth Century Studies, University of Wisconsin-Milwaukee and Professor and Chair of the Department of Political Science at the University of Wisconsin-Parkside. His publications include *The Elements of Social Scientific Thinking* (5th edition, St Martin's Press, 1992) and, with Raymond Plant, *Conservative Capitalism in Great Britain and the United States: A Critical Appraisal* (Routledge, 1989). His current research interests are contemporary ideologies, the Mondragon co-operatives and methodology.

**Jeffrey C. Isaac** is Associate Professor of Political Science at Indiana University, Bloomington. His publications include *Power and Marxist Theory: A Realist View* (Cornell University Press, 1987) and articles in such journals as *Polity*, *Political Theory*, *History of Political Thought* and *Praxis International*. He has just completed a book on the political writings of Hannah Arendt and Albert Camus.

**Rita Mae Kelly** is a Professor of Justice Studies, Political Science and Women's Studies at Arizona State University, Tempe. She was President of the Policy Studies Organization (1988-9) and of the Western Political Science Association (1988-9), and was the editor of *Women and Politics* from 1986 to 1991. Her publications include *Advances in Policy Studies since 1950* (Transaction Press, 1982), *Comparable Worth, Pay Equity and Public Policy* (Greenwood Press, 1988), *Women and the Arizona Political Process* (University Press of America, 1988), *Productivity in the Public Sector* (St. Martin's Press, 1988), *Gender, Bureaucracy and Democracy* (Greenwood Press, 1989) and *The Gendered Economy* (Transaction Press, 1991). She is currently working on projects concerning women and politics and feminism and policy studies.

**Robert O. Keohane** is Stanfield Professor of International Peace and Chair of the Department of Government, Harvard University. He received the second annual Grawemeyer Award for Ideas Improving World Order for *After Hegemony: Cooperation and Discord in the World Political Economy* (Princeton University Press, 1984). He is co-author,

with J.S.Nye, of *Power and Interdependence: World Politics in Transition* (Little, Brown & Co., 1977) and also wrote *International Institutions and State Power: Essays in International Relations Theory* (Westview Press, 1989).

**Samuel S.Kim** is Lecturer in Public and International Affairs at the Woodrow Wilson School of Public and International Affairs, Princeton University. His publications include *China, the United Nations, and World Order* (Princeton University Press, 1979), *The Quest for a Just World Order* (Westview Press, 1984), and as co-editor, *The United Nations and a Just World Order* (Westview Press, 1991) and *China's Quest for National Identity* (Cornell University Press, 1992). His current research includes several projects on East Asian international relations and world order issues.

**Peter Knoepfel** is Professor of Comparative Public Administration and Public Policies at the Institute for Advanced Studies in Public Administration, Lausanne. He is a member of the Committee of the Swiss Association of Political Sciences and President of the Swiss Commission of Observation of the Environment. His research interests concern comparative environmental policies in air pollution and agriculturally induced water pollution.

**Maurice Kogan** is Professor of Government and Social Administration and Joint Director of the Centre for the Evaluation of Public Policy and Practice at Brunel University. He is the author or joint author of several works on educational, health, higher education, social services and science policy and on the struggle for power in the British Labour Party.

**David Kowalewski** is Associate Professor of Political Science at Alfred University, Alfred, New York. His publications include *Transnational Corporations and Caribbean Inequalities* (Praeger, 1982). His articles on international organizations have appeared in journals including *Comparative Political Studies* and the *Journal of Political and Military Sociology*. He is currently researching the political economy of Asia.

**Joseph LaPalombara** is the Arnold Wolfers Professor of Political Science at Yale University, where he also directs the Institution for Social and Policy Studies. **Joni Lovenduski** is Reader in Politics at Loughborough University. In 1986 she became Convenor of the Standing Group on Women and Politics of the European Consortium for Political Research. Her publications include *Women and European Politics* (Harvester Wheatsheaf, 1986) and, as co-editor, *The New Politics of Abortion* (Sage, 1986) and, with J.Hills, *The Politics of the Second Electorate: Women and Public Participation* (Routledge & Kegan Paul, 1981).

**Robin W.Lovin** is Associate Professor of Ethics and Society at the Divinity School of the University of Chicago, where he has been a member of the faculty since 1978. He previously taught at Emory University, Atlanta, Georgia. His publications include *Christian Faith and Public Choices* (1984) and *Religion and American Public Life* (Paulist Press, 1986).

**Denis McQuail** is Professor of Mass Communication at the University of Amsterdam, and previously taught in the Sociology Department of Southampton University. He has served as Academic Adviser to the British Royal Commission on the Press and to the Scientific Council for Government Policy in the Netherlands. In 1989 he was Senior Research Fellow at the Gannett Center for Media Studies, Columbia University. His publications include *Mass Communication Theory* (Sage, 1983 and 1987) and, as co-editor, *New Media Politics* (Euromedia Research Group, 1986) and *Electronic Media and Politics in Western Europe: A Handbook* (Euromedia Research Group, 1986). **Edward McWhinney** is a member of the Institut de Droit International and the Académie Internationale de Droit Comparé and was a member of the Permanent Court of Arbitration from 1985 to 1991. He has taught at Yale and held chairs in leading US and Canadian universities. He is currently Professor of International Law and Relations at Simon Fraser University, Vancouver. He has been a Visiting Professor at many world centres including the Max-Planck-Institut, the Meiji University, Tokyo, the University of Paris I (Sorbonne), the Collège de France and the Hague Academy of International Law. **James M.Malloy** is Professor of Political Science and Research Professor at the University Center for International Studies, University of Pittsburgh. His publications include, as co-editor with M.A.Seligson, *Authoritarians and Democrats: Regime Transition in Latin America* (University of Pittsburgh Press, 1987). He is presently working on issues of regime transition, economic adjustment and the role of private sector interest groups in Latin America.

**Talukder Maniruzzaman** is Professor of Political Science at the University of Dhaka. He was Professor and Head of the Department of Political Science at the University of Rajshahi, Bangladesh, and has won several scholarships and fellowships, including the Nuffield Foundation Fellowship at the University of London and a fellowship at the Woodrow Wilson International Center for Scholars, Washington DC. **Martin N. Marger** is Associate Professor of Sociology at Michigan State University. He taught previously at Waynesburg College and Northern Kentucky University. His publications include *Elites and Masses* (2nd edition, Wadsworth, 1989) and *Race and Ethnic Relations: American and Global Perspectives* (2nd edition, Wadsworth, 1991). His current research interests focus on the processes of economic and social adaptation among immigrants.

**Geoffrey Marshall** is a Fellow of Queen's College, Oxford and an Oxford University lecturer in politics, where he has been teaching since 1957. He has been Assistant Editor of *Public Law* since 1960. **T. David Mason** is Associate Professor of Political Science at Mississippi State University, where he also holds partial appointments with the university's Social Science Research Center and the Center for International Security and Strategic Studies. His research on civil violence has appeared in many anthologies and journals, including *Western Political Quarterly*, *Asian Affairs* and *Studies in Comparative International Development*. He is co-editor of *US-Japan Trade Friction: Its Impact on Security Cooperation in the Pacific Basin* (Macmillan, 1991).

**Sonia Mazey** is Lecturer in Politics in the Government Department of Brunel University. She has published several articles on French politics and European Community policy making. She is co-editor of *Mitterrand's France* (Croom Helm, 1987) and co-author of *The European Community: Developments and Issues* (McGraw-Hill, forthcoming).

**Toivo Miljan** is a Professor in the Department of Political Science at Wilfrid Laurier University, and has been Adjunct Professor of Political Science at the Swedish School of Business and Economics, Helsinki, since 1988. He is the Co-director of the Centre of Foreign Policy and Federalism. **George Modelski** is Professor of Political Science at the University of Washington. He was a member of the Institute of Advanced Studies, Australian National University from 1957 to 1967. **Craig N. Murphy** is Associate Professor of Political Science at Wellesley College, Massachusetts. **John D. Nagle** is Professor of Political Science at the Maxwell School of Syracuse University, New York. He held a Fulbright Senior Research Fellowship in Germany in 1974–5, and a research position with the Library of the Bundestag in 1976. His publications include *The National Democratic Party of Germany* (University of California Press, 1970), *System and Succession: The Social Bases of Political Elite Recruitment* (University of Texas Press, 1977), which was supported by the American Philosophical Association and the Conference Group on German Politics, and *Introduction to Comparative Politics: Political System Performance in Three Worlds* (3rd edition, Nelson-Hall Publishers, 1992).

**Kai Nielsen** is Professor and Head of the Department of Philosophy at the University of Calgary. He is a past President of the Canadian Philosophical Association, and is a member of the Royal Society of Canada. His publications include *Equality and Liberty: A Defense of Radical Egalitarianism* (Rowman & Allenheld, 1985) and *Marxism and the Moral Point of View* (Westview Press, 1989).

**Robert C. Oberst** is Associate Professor of Political Science at Nebraska Wesleyan University. He has published extensively in scholarly journals about Sri Lanka and is a co-author of *Politics and Government in South Asia*.

**Øyvind Østerud** is Professor of International Conflict Studies in the Department of Political Science, University of Oslo. He was a Visiting Scholar at the London School of

Economics in 1983 and at the Australian National University, 1987–8. His publications include *Agrarian Structure and Peasant Politics* (1978) and, as editor, *Studies of War and Peace* (Norwegian and Oxford University Press, 1986). His current research interests include sovereign statehood and nationality conflicts, decolonization and the politics of the Third World, and superpower rivalry and regional conflicts.

**Michael Pacione** is Reader and Head of the Department of Geography at the University of Strathclyde, Glasgow. He has held academic positions at Queen's, Belfast, and was Visiting Professor at the University of Guelph, Ontario. **Stanley G. Payne** is Hilldale-Jaime Vicens Vives Professor of History at the University of Wisconsin-Madison. He is the author of *Fascism: Comparison and Definition* (University of Wisconsin Press, 1980) and of numerous works on Spanish and Portuguese history, including *Falange: A History of Spanish Fascism* (1961) and *The Franco Regime 1936–1975* (University of Wisconsin Press, 1987).

**George Philip** is Reader in Comparative and Latin American Politics at the London School of Economics and Political Science. He is the author of *Oil and Politics in Latin America* (Cambridge University Press, 1982), *The Military in Latin American Politics* (Croom Helm, 1985) and *The Presidency in Mexican Politics* (Macmillan, 1992).

**Adamantia Pollis** is Professor of Political Science in the Graduate Faculty at the New School for Social Research, New York. She has been Visiting Professor at the University of the Aegean and has also taught at City University of New York (Queens College), Columbia University and Essex University. She has written extensively on various aspects of human rights and the politics of Greece, Turkey and Cyprus. Her publications include, as editor, *The Contemporary Mediterranean World* (Praeger, 1983), and as co-editor with Peter Schwab, *Toward a Human Rights Framework* (Praeger, 1982), and *Human Rights: Cultural and Ideological Perspectives* (Praeger, 1979).

**G.Bingham Powell** is Professor of Political Science at the University of Rochester, New York, where he was Chair of the Department 1986–9. He is co-author of *Comparative Politics: System, Process and Policy* (1978) and author of *Contemporary Democracies: Participation, Stability and Violence* (Harvard University Press, 1982), which in 1983 won the American Political Science Association's Woodrow Wilson Prize for the best book in Political Science in the previous year. His current research is focused on conditions for citizen influence in contemporary democracies.

**David C.Rapoport** has taught Political Theory at the University of California at Los Angeles since 1961. His many publications include *Assassination and Terrorism* (CBC, 1971), *The Morality of Terrorism*, as co-editor (2nd edition, 1988) and *Inside Terrorist Organizations*, as editor (Columbia University Press, 1989). **Bernard Reich** is Professor of Political Science and International Affairs and Chair of the Department of Political Science at George Washington University, Washington, DC. **Stanley A.Renshon** is a member of the Political Science Faculty of the City University of New York (Herbert Lehman College and the Graduate School and University Center). He is the author of *Psychological Needs and Political Behaviour: A Theory of Personality and Political Efficacy* (Free Press, 1974), is editor of the *Handbook of Political Socialization: Theory and Research* (Free Press, 1977) and has published numerous articles on political psychology and behaviour. He was appointed editor of the journal *Political Psychology* in 1989.

**R.A.W.Rhodes** is Professor of Politics and Head of Department at the University of York. He has taught at the Universities of Birmingham, Strathclyde and Essex. His publications include *The National World of Local Government* (Allen & Unwin, 1986) and *Beyond Westminster and Whitehall* (Unwin Hyman, 1988). He is the editor of *Public Administration* (the journal of the Royal Institute of Public Administration). His current research focuses on policy networks in British government, British contributions to administrative theory and the implementation of Thatcherite policies.

**Shamit Saggat** is a lecturer in politics at the University of London (Queen Mary and Westfield College) and has also taught at the Universities of Essex and Liverpool.
